# A SPECIAL MEETING OF THE OSCODA COUNTY LIBRARY BOARD WAS HELD ON MONDAY, JANUARY 5, 2015 AT 5:30 P.M. AT THE OSCODA COUNTY LIBRARY.

#### **Special Meeting Business**

#### **Phase II - Painting**

There will be an additional charge of \$75.00 if the window in the bookroom needs to be sealed and stained. The Library will furnish the paint.

Vice Chair Stenzel stated she had her business doors painted with auto paint at a local collision shop. She said the doors are easy to care for and she has had no rust.

Call/Shumaker Motion to accept the bid from Don Davis in the amount of \$3,600.00 with 50% down and the balance upon completion.
