The parking lot has two pressure cracks – one running north and south and the other east and west. The current lot was put down in 2001 or 2002. Director Knepp will check with Dennis Morse to see if he knows of companies who can repair/replace the lot. Do we need a permit? Director Knepp will check with Tim Whiting at the Building Department.

Biblioboard

The board discussed the usage by the community. There may be grant money available to pay the cost of Biblioboard. If subscribed to, the board would like to see a usage report at the end of the 11th month prior to renewing. Secretary Shumaker asked what would happen if local authors plagiarized. Would the Library be liable? The staff will market. Director Knepp will see if she can get another trial so the board can review.

Signage for Fairview

The board reviewed signage for the Fairview branch. Cost for the sign over the outside door is \$250.00 and \$500.00 for the two signs that will be placed on the plaza sign seen from the road (east & west).
