Minutes

The minutes from the February 21, 2022 regular meeting and March 2, 2022 special meeting stand approved as presented.

AppointmentTony Radjenovich – MERSMr. Radjenovich addressed the Board with regards to termination of the MERS
retirement plan. He stated the following:

- a district library does not qualify as a municipality.
- the district library must have a municipality to guarantee the cost.
- a defined benefit will be available to the recipient for as long as he/she is alive.

He brought a document, "MERS Retirement Board Termination Policy & Procedure" and referred to several phases with regards to termination.

Moving completely away from MERS to a new successor means attorneys from both parties must complete all legal documents.

Board members reiterated that complete termination of the MERS plan is the route they wish to take.

Additional MERS Discussion

One of the Board's attorney, Mindi Johnson, emailed the names of two possible entities that could offer comparable retirement plans upon termination of the MERS plan.

Anne Seurynck, the Library's district library attorney, said the Oscoda County Library and the Oscoda County District Library can co-exist until the district library is finalized.
