# **Budget Report**

#### **Old Business**

### Oak Wilt on Trees Along Property Line

Three trees between the Library and church next door have oak wilt. The pastor has offered to have church member take trees down and remove debris. Two other trees on the corner of the Library's property may/may not have oak wilt.

Motion to have 3 trees cut down by the church group. They will have to clean up and assume liability for any issues that might come up.

# 2013 Budget

The board reviewed the 2013 budget then tabled any further action since board members need information on the following:

- 1. Health insurance consult Mike Hunt. Does the county consider Library employees as county employees for the purpose of insurance?
- 2. What is the number of hours used to determine full-time vs. part-time employment? Is there a change from 2012 to 2013?

Chairman Olsen and Director Knepp will create a calendar in Google to indicate when we will be purchasing items based on the 4-year plan. This can also be used as an informational tool for the public.

#### **New Business**

#### **New Hours**

Director Knepp related that patrons have asked if the increase in hours will take effect sooner rather than later. Board members Call and Shumaker felt the new hours should take effect on January 1, 2013 as Director Knepp needs to schedule staff and post calendar. New hours need to be publicized. The board does not have funds to increase staffing in 2012. After discussion, the board agreed new hours will start on January 1, 2013.

### **Satellite Library**

Kevin Salsbury (pastor - Comins Mennonite Church) approached Director Knepp about offering the church to be used as a satellite of the Library. He suggested that MeL books and other holds could be dropped off at the church and community members could pick them up there. Director Knepp is concerned about privacy issues. The board decided to table the item and will revisit it at a later date.

# **Planning**

Chairman Olsen would like the board to review the spending plan at each meeting. Board members agreed to this idea.

### **Director's Comments**

Director Knepp reported we will have an author speaking at the Library in May 2013. He is a police officer with post-traumatic stress disorder. This falls under adult programming in the 4-year plan and will cost \$50.
